**Minutes of the Council Meeting of Patrington Parish Council
Held in Patrington Village Hall on 10th May 2021 at 7.15 pm**

15) **ERYC UPDATE FROM WARD COUNCILLOR;** Cllr C Holmes was elected at the by-election on May 6th as a ward councillor for South east Holderness. Cllr Holmes addressed the meeting, her role as Ward Councillor will complement the role of Parish Chair, and encouraged the Parish Councillors to give people her mobile or email address if they have any concerns about the Ward and to continue using the existing contact details for concerns or comments within the Parish.

16) **PARISHIONERS QUESTIONS:**

- I. Mr Walker addressed the meeting and answered questions on his on the Patrington Poppy Project. The event will take place at the end of October and the plastic poppies will be placed around the village. Mr Walker thanked the Parish Council for the donation of £100 and will keep the Council updated.
- II. Mrs C Young addressed the meeting and spoke about the litter picking that she has completed with her husband around Winestead. Mrs Young is concerned with the amount of litter that is regularly disposed of along grass verges and has reported her incidents of fly tipping to ERYC who have dealt with the matter. Cllr D Snaith thanked Mrs Young and her husband for the work they have completed.

- i. 21/00720/PLF Change of use of land for siting of lodges and associated operational development (resubmission 20/01077/PLF) The White Hall Patrington Road Winstead Mr R Kelly Full Planning Permission. *The Council were unable to make a decision as the information had not been updated and an extension has been granted from ERYC.*
