- 115) **ERYC UPDATE FROM WARD COUNCILLOR;** Ward Cllr C Holmes gave a verbal report to the meeting including a update about Holderness Health and she had applied for the ERYC grant and received funding for the stage/notice board/ERYC band and funding for other activities to be held in the village.

- a) **Churchyard meeting with PCC**
