140) ERYC UPDATE FROM WARD COUNCILLOR; Ward Cllr C Holmes gave a verbal report

Holderness Health have been operating with extremely high absence levels driven largely by COVID isolation and positive cases since before Christmas.

Patients will be offered appointments at Patrington when these are available. For GPs, these follow the same format as for appointments at all their sites i.e. a telephone consultation first followed by a face to face if necessary. So, for example, if a GP working at Patrington spoke to a patient in the morning and needed to see that patient in person, they would normally offer them a face to face slot in Patrington in the afternoon. For nursing appointments, these will sometimes be general nursing appointments and sometimes specific clinics. If an appointment is available at another surgery sooner this is why an appointment may be offered at Withernsea or Hedon.

Regarding urine samples, these can not be accepted at Patrington unless there is a nurse available on site as samples must be dipped on-site and within an appropriate time frame. Therefore, unless a nurse is on site, patients will be asked to drop their sample off a one of the main sites where it can be dealt with immediately. Because of the staffing difficulties it can not be guaranteed that there will be a nurse at Patrington when a patient brings a sample in. For that reason patients may temporarily be asked to take them to Hedon or Withernsea. When staffing levels return to normal patients will be able to take them to Patrington again.

Holderness Health have stressed that this is a temporary problem caused by Covid and they have absolutely no plans to close our surgery in Patrington.

The path outside the cemetery has been reported to ERYC who will update in due course on progress.
