**Minutes of the Council Meeting of Patrington Parish Council
Held in Patrington Village Hall on 9th October 2023 at 7.00 pm**

- 87) **ERYC UPDATE FROM WARD COUNCILLOR;** No ward Councillor present.

- 90) **DECLARATIONS OF PERSONAL AND PREDJUDICIAL INTERESTS:** Cllr J Edmunds item 8(a) II Personal interest in planning application.
- 91) **MINUTES OF PREVIOUS MEETING HELD ON 11th SEPTEMBER 2023:**
The minutes of the meeting held on 11th September 2023 after being duly circulated were adopted as a true record. Proposed Cllr M Heap and seconded Cllr H Murphy. Unanimously agreed.
- 92) **RESIGNATION OF CHAIR**
Councillor Holmes has sent a letter of resignation from the Parish Council and resigned as Chair and Councillor, the meeting unanimously agreed the Clerk would send a letter of thanks to Cllr Holmes and thank her for the work she did for the Parish over the last 3 years. Cllr C Tuplin proposed Cllr H Murphy as Chair and Seconded Cllr R Snaith. Unanimously agreed.
- 93) **MATTERS ARISING FROM THE ABOVE MEETING:**
- a) **Christmas Lights and Switch on Event** – The Clerk gave a verbal report, the road closure will cost £287 and the meeting agreed to pay this. Large tree ordered, stalls arranged and Father Christmas is coming. Selection boxes need to be purchased and the school will sing as well as Withernsea Ladies Choir. PJD hope to commence work weekend 28/29 October.
 - b) **Hanging Baskets** – The hanging baskets need to be taken down, this will be done over the next 2 weeks.
 - c) **Defibrillator** – The Clerk has contacted the school and they have confirmed they have their own defib in the school and agreed that we can remove the outside cabinet and the cabinet will be moved to the Village Hall and a new defib will be purchased.
