**Minutes of the Council Meeting of Patrington Parish Council  
Held in Patrington Village Hall on 8<sup>th</sup> January 2024 at 7.00 pm**

- 130) **COUNCILLORS PRESENT:** Mrs H Murphy (Chair), Mr T Bearpark, Mr M Heap, Mrs C Hull, Mrs C Lythe, Mrs K Mckinley, Mrs J Ralph, Mr D Snaith, Mr R Snaith and Cllr A Tuniewicz

- 132) **ERYC UPDATE FROM WARD COUNCILLOR:** No Ward Councillor present.
- 133) **PARISHIONERS QUESTIONS :** Mr Brewood addressed the meeting and explained that his internet speed at Enholmes is very slow and asked if the Parish Council could offer any help. The Clerk is to contact ERYC Broadband and the Chair is going to speak to MP Graham Stuart. Mr Breywood left the meeting at 7.15pm.

- 135) **DECLARATIONS OF PERSONAL AND PREDJUDICIAL INTERESTS:** None
- 136) **MINUTES OF PREVIOUS MEETING HELD ON 11<sup>th</sup> DECEMBER 2023:**  
The minutes of the meeting held on 11<sup>th</sup> December 2023 after being duly circulated were adopted as a true record. Proposed Cllr K Mckinley and seconded Cllr T Bearpark. Unanimously agreed.
- 137) **MATTERS ARISING FROM THE ABOVE MEETING:**
- a) **Christmas Lights** – The lights and trees will be coming down Sunday 14<sup>th</sup> January. It was discussed that new lights for the large tree that are brighter would be a great addition to the Christmas lights.
  - b) **Speeding vehicles within the Parish** - The meeting discussed and agreed to ask the police to patrol the area more and where possible visit the school during drop off and pick up times. It was suggested that pupils of Patrington Primary could design posters, which could be placed around the village to reduce speeding.

*At a meeting held on Monday 8/1/2024 the Parish Council agreed to strongly object to the application. The reasons are the same as the decision made on 10/5/2022 and they feel that the information provided is not sufficient and gives no reason for them to change their decision. There are still concerns about the access. There is a large amount of support however very few are from the Parish and the letters of objection are from people who live near the proposed site and their concerns and issues raised are those of the Parish council as well. As previously said the Parish Council understand that animal welfare is extremely important but the need for this new development would have a detrimental effect on the existing wildlife in the area and there are other rescue centres in the surrounding area.*
